I. <u>SUMMARY</u>

The Niagara Frontier Transportation Authority (NFTA) has established a Disadvantaged Business Enterprise Program in accordance with the regulations of the United States Department of Transportation (USDOT), Code of Federal Regulations Title 49 Part 26 (49CFR26), as a requirement of the federal regulations, NFTA must submit triennially a DBE agency-wide goal, and a narrative that describes the methodology by which the agency arrived at the goal. This document contains NFTA's DBE agency goal for Federal Fiscal Years 2025 through 2027 (FFY 2025-2027) and the methodology that NFTA used to arrive at the goal.

The NFTA has determined that its annual DBE goal for FFY 2025-2027 to be 17% of the total federal finical assistance that NFTA will expend on Federal Transit Administration (FTA) funded contracts. NFTA projects that 7.52% of the total funding that will expend on federally assisted projects for this period can be achieved through race and gender-neutral means or methods, and the remaining 9.48% can be achieved through race and gender conscious means or methods.

- Developing a Mentor-Protégé program
- Improving access to bonding and capital for DBEs
- Prime and DBE Networking
- Unbundling of lager contracts

The NFTA will seek to attain the maximum feasible portion of its DBE goal utilizing race and gender-neutral means. Race and general-neutral DBE participation and race and gender-conscious DBEs are monitored by NFTA's Office of Equal Employment Opportunity and Diversity Development monthly, and adjustments are made quarterly to ensure the NFTA does not fall short of meeting its DBE goal on an annual and overall basis.

To develop its goal, NFTA used the FTA approved "DBE Directory and Census Bureau" method, utilizing DBE directories from eight counties - Cattaraugus, Chautauqua, Erie, Genesee, Monroe, Niagara, Orleans, and Wyoming.

For public participation, the NFTA held a public meeting on July 5th, 2024, where it announced its goal. The NFTA took part in public comments at the meeting and engaged in a 14-day public comment period from July 5, 2024, to July 19, 2024. The NFTA responded to all comments and posted the responses on its website on https://www.nfta.com/about/human-resource/eeo-diversity-development

II. INTRODUCTION

Pursuant to 49 CFR Part 26 "Participation by Disadvantaged Business Enterprises in Department of Transportation Financial Programs", NFTA sets forth its Triennial DBE Agency Goal and corresponding goal-setting methodology for FFY 2025-2027 (October 1, 2024, through September 30, 2027). The purpose of the DBE goal setting process is to ensure nondiscrimination in the awarding of USDOT-assisted contracts, to create a level playing field on which DBEs can compete fairly for those contracts, and to ensure the DBE Program is narrowly tailored in accordance with applicable law.

III. BACKGROUND

The NFTA is a Tier I recipient of USDOT FTA funding in excess of \$670,000. As a condition of receiving this financial assistance, NFTA has assured the FTA that it will comply with FTA's DBE requirements. Therefore, in accordance with 49 CFR Part 26.45(a)(1), the NFTA is required to develop and submit triennially to the FTA an overall DBE agency goal for its FTA-assisted projects.

IV. FTA ASSISTED CONTRACTING PROGRAMING (FFY 2025-2027)

Table 1 represents the NFTA's projected FTA-assisted contracting program for FFY 2025-2027, which consists of 10 projects considered in preparing this goal methodology. These projects are anticipated to be awarded through contracts during the triennial period.

Step One: Determining the Base Figure – 49 CFR 26.45(c)

a. Determining the weight of each type of work by NAICS Code

Tables 2 provides a summary of the Categories of Work along with their estimated cost. Categories of Work are groups utilizing comparable North American Industry Classification System (NAICS) codes for purposes of weighting them based on operational budgets.

Market Area Analysis

The NFTAs market area consists of the geographical area where the majority of contracting and subcontracting dollars are quoted, bid-on, and/or expended. This area includes the following eight counties - Cattaraugus, Chautauqua, Erie, Genesee, Monroe, Niagara, Orleans, and Wyoming.

Base Figure Analysis

In determining the Base Figure of ready, willing, and able (RWA) DBEs to all RWA firms available to bid or propose on NFTA FTA-assisted contracting opportunities projected to be solicited during the triennial goal period, the NFTA followed the prescribed federal methodology to determine relative availability: The New York State Unified Certification Program (NYSUCP) DBE Directory of Certified Firms was used to provide the number of RWA DBE firms within the NFTAs market area by NAICS code, and the 2021 U.S. Census Bureau County Business Pattern was used to provide the number of all RWA firms within NFTAs market area by NAICS code.

c. Weighted Base Figure

To ensure the Step One Base Figure is as accurate as possible for DBE goal setting, the weight of each NAICS code (see Table 2) was multiplied by the Relative Availability of DBEs (see Table 3) to arrive at the Weighted Base Figure. The result of the Step One Weighted Base Figure calculation is **22.6%** (see Table 4).

Step Two: Adjusting the Base Figure – 49 CFR 26.45(d)

Upon establishing the Step One Base Figure of 22.6%, the NFTA assessed other known evidence potentially impacting the relative availability of DBEs within the market area. The evidence considered in making an adjustment to the Base Figure includes past DBE goal attainments and other evidence.

Adjustments Based on Past Participation Analysis

Historical DBE participation attainment provides demonstrable evidence of DBE availability and capacity to perform on NFTA projects. The projects anticipated to be awarded during this triennial period are similar in scope to those awarded in the recent years.

Finding the Adjusted Base Figure Analysis

In finding the Adjusted Base Figure – making sure not to give disproportionate weight to past participation – the NFTA averaged the Step One Base Figure with the Median DBE Attainment percentage found in Table 5. These two percentages were added together and then divided by two (2), resulting in a rounded Step Two Adjusted Base Figure of **17.7%** (see Table 6).

Bidders List

Currently, the NFTAs bidders list does not provide sufficient data to justify an adjustment to the Base Figure. However, bidders list information will continue to be collected on future procurements for the potential use in future DBE goal determinations.

Disparity Study

The NFTA is not aware of any current disparity studies within their jurisdiction and/or market area to consider in this step of the goal setting analysis.

Other Available Evidence

The NFTA is not in possession of other information that would impact the DBE goal assessment.

VI. PROPOSED OVERALL DBE GOAL

Based on the above methodology, the NFTA has established a Disadvantaged Business Enterprise (DBE) goal of 17.7% for FFY 2025-2027. However, the NFTA does recommend that the overall DBE goal be set to **17.0%** based on past utilization.

VII. <u>CALCULATING THE RACE/GENDER-NEUTRAL AND RACE/GENDER-</u> <u>CONSCIOUS SPLIT</u>

The NFTA will strive to achieve the entire DBE goal (17%) through race-neutral (RN) means; however, effort will be made to obtain DBE participation through race-conscious (RC) means if race-neutral means are unsuccessful.

Past Race-Neutral and Race-Conscious Goals

In determining the race-neutral and race-conscious split for this triennial period, the NFTA considered how past RN and RC participation compared to the RN and RC goals set during those years. The past years used in this determination were 2022-2024.

In determining whether to increase or decrease the race-neutral and race-conscious split for this triennial period, the NFTA first determined the *Goal Difference* for each year. To explain this in clearer terms, the NFTA calculated how much the race-neutral and race-conscious *Attained Goals* went above or below the *Projected Goals* (per year). To find the Goal Difference, the NFTA subtracted the Projected Goal from the Attained Goal (per year). The Projected and Attained goal percentages were found in the NFTA biannual FTA DBE reports submitted via TrAMS for 2022-2024.

Once the Goal Difference for both years was established, the *mean* had to be determined. To find the mean for the race-neutral goal, we first added -9.48%, -9.48%, and -1.07% to get 20.03%. We then divided 20.03% by 3 (the total number of values in the calculation) and arrived at -6.67%. The same methodology was used to find the race-conscious mean.

Table 7a shows a past participation race-neutral goal decrease of **6.67%**, decreasing the overall race-neutral goal from 9.48% to **2.81%** for this triennial period.

Table 7b shows a past participation race-conscious goal decrease of **1.86%**, decreasing the overall race-conscious goal from 7.52% to **5.66%** for this triennial period.

Adjusted Race-Neutral and Race-Conscious Split

With the Adjusted Base Figure Proposed DBE Goal at 17.7%, the adjusted raceneutral and race-conscious split currently adds up to 8.47%. In order for the split to reach the proposed goal of 17%, the NFTA will increase the race-conscious goal to 9.48% (from 7.52%) and decrease the race-neutral goal to 7.52%. This will establish a new race-neutral and race-conscious split of **7.52%** (RN) and **9.48%** (RC), totaling 17%.

Plans to Implement New Race-Neutral Methods

In doing so, the NFTA will use the following means to increase race-neutral participation during this triennial period:

- The NFTA will encourage contractors to utilize DBE subcontractors on projects
- The NFTA will encourage Prime Contractors to subcontract portions of work to DBEs that otherwise would be done internally.
- Representatives from the NFTA will participate in outreach activities each year to provide information about DBE certification and contracting opportunities with the NFTA. Some of the outreach events that the NFTA has participated in the past are:
 - o Local woman, minority and Veteran's Business Fair sponsored by UB Gateway
 - o Business matchmaking event sponsored by US Small Business Administration
 - o Western New York Regional MWBE Opportunities Expo sponsored by NYS Division of Minority & Woman's Business Development
 - o NYS MWBE Forum hosted by Empire State Development
 - o Small Business Administration opportunities workshops hosted by Buffalo State College
 - o Small Business Networking event hosted by Canisius College Woman's Business Center
 - o Buffalo Niagara Medical Campus Small Business Matchmaker
 - o "Get on the Bus Tours Selling to Government" sponsored by Erie County Medical Center
 - o Opening doors to Government Contracting sponsored by the Small Business Administration and Buffalo Niagara SCORE.

VIII. PUBLIC PARTICIPATION AND FACILITATION

In accordance with Public Participation Regulatory Requirements of Title 49 CFR Part 26, minority, women, local business associations, and community organizations within the NFTAs market area were consulted and provided an opportunity to review the triennial goal analysis and provide input (see Attachment 1). Upon public review, the summary of comments did not suggest the need to change the proposed DBE goal percentage for this triennial period.

The NFTA published a notice announcing the proposed overall goal informing the public that the proposed goal and its rational were available for inspection during normal business hours at the NFTA office of Equal Employment Opportunity / Diversity Development (see Attachment 2). The NFTA reached out to local minority, women, and community business organizations to provide them information on the NFTA DBE program and specifically the Draft Proposed FTA Overall DBE Goal-Setting Methodology for FFY 2025-2027. Each organization was contacted by telephone and email. A summary of all contact made in an attempt to receive input as a part of this process can be found in Attachments 2 through 5.

IX. <u>CONCLUSION</u>

On an annual basis, at the conclusion of each federal fiscal year, the NFTA will analyze the DBE awards and commitments reported to the FTA on a biannual basis. If the DBE awards/commitments are less than the overall DBE agency goal, the NFTA will develop and submit a written analysis of the shortfall, as well as the corrective actions implemented to remedy the shortfall during the next federal fiscal year. Also, if any significant changes are made to the NFTA's FTA-assisted contracting program, and/or any significant changes occur in DBE participation on NFTA contracts, the NFTA will, if warranted, re-calculate the overall DBE agency goal and submit an adjusted overall DBE goal to the FTA.


